## **TWO COURT REQUIRED BANKRUPTCY CREDIT COUNSELING COURSES**

Two sequential credit counseling courses are required in every bankruptcy filing:

The FIRST course is called simply the "**Credit Counseling Course**." You MUST do this course BEFORE YOU FILE BANKRUPTCY. This usually takes about 1 hour.

The SECOND, post filing course, is called the "**Debtor's Education**" or "Financial Management" course. Both courses may be taken on line or can be done by phone if you do not have a computer. After you take each course – and review the comments by a counselor – a certificate stating when you completed the course will be sent to you and to our office. Please make sure you review the counselor's comments, or you will not be issued a certificate of completion!

- The first(Credit Counseling Course) may be taken up to 6 months BEFORE your case is filed with the court, but the certificate MUST BE RECEIVED BY OUR LAW OFFICE BEFORE WE CAN FILE YOUR CASE. Usually we can get a completed certificate within 48 hours from the counseling companies.
- The second (Debtor's Education or Financial Management Course), must be taken after you file, but when it is due depends on whether you are chapter 7 or chapter 13.

CHAPTER 7 - must be received no later than 60 days after your 341 Trustee Meeting CHAPTER 13 - must be taken by the end of your Plan

The courses are given by a variety of non-profit organizations. While an organization may not provide both courses, there are frequently linked or 'sister' organizations that each provide one of the courses. Prices range from \$15 to \$35 per course.

Many entities are approved for Colorado, but we have found that the following 3 organizations consistently provide good service, quick certificate issuance, and are affordable. (In alphabetical order by the organization providing the first course).
